If your New York AGI is **more than \$107,650, but not more than \$25,000,000**, and your taxable income is **\$215,400 or less**, then you must compute your tax using this worksheet.

1. Enter your New York AGI	1.	0.
2. Enter your taxable income	2.	0.
3. Multiply line 2 by 6% (0.06) (Stop: if the line 1 amount is \$157,650 or more , skip lines 4 through 8 and enter the line 3 amount on line 9)	3.	0.
4. Enter your New York State tax on the line 2 amount from the <i>New York State tax rate schedule</i>	4.	0.
5. Subtract line 4 from line 3	5.	0.
6. Enter the excess of line 1 over \$107,650	6.	0.
7. Divide line 6 by \$50,000	7.	0.0000
8. Multiply line 5 by line 7	8.	0.
9. Add lines 4 and 8 Enter here and on Form IT-201, line 39 or Form IT-203, line 38	9.	0.

If your New York AGI is **more than \$215,400, but not more than \$25,000,000**, and your taxable income is **more than \$215,400 but not more than \$1,077,550**, then you must compute your tax using this worksheet.

3. Enter your New York State tax on the line 2 amount from the <i>New York State tax rate schedule</i>	3.	0.

3. Enter your New York State tax on the line 2 amount from the New York State tax rate schedule	3.	0.
4. Recapture base amount	4.	0.
5. Incremental benefit amount	5.	0.
6. Enter the excess of line 1 over \$1,077,550	6.	0.
7. Enter the lesser of line 6 or \$50,000	7.	0.
8. Divide line 7 by \$50,000	8.	0.0000
